



## EAGLE CREEK CAMPGROUND AND EVENT CENTRE RULES & POLICIES

### WELCOME

To ensure a great experience for everyone, we've outlined some common-sense rules. Please review them before your visit. If you have questions, ask any staff member—we're happy to help!

### MEMBERSHIP AND PARK ACCESS

- Eagle Creek is a private, membership-only campground for individuals aged 18+ with valid photo ID.
- Membership is required before arriving. Failure to provide proof of membership will incur a \$15 fee.
- Misconduct or rule violations may result in revoked access without a refund.
- Register all repair, maintenance, or delivery personnel with the park staff in advance.
- Members must have a valid reservation, day pass, or overnight guest pass registered and paid prior to arrival.
- Reservation, Day Pass, and Overnight Guest rates are subject to change. See the online booking portal or store for current rates.

### GUEST CHECK-IN AND CHECK-OUT

- Check-in policies apply to all site/room/cabin bookings and seasonal site guests.
- Each person attending the property for any reason or length of time must check-in with management from the gate prior to entering the property.
- **Check-in:** 2:00 pm - 8:00 pm
  - Early check-in subject to availability.
  - Late check-in may be accommodated with advance notice. Arrangements must be made with management in advance. Additional fees may apply.
- **Check-out:** 12:00 pm is the standard check-out time.
  - Members are free to enjoy the property for the remainder of the day. Should we have need for a quick turnaround on your booked space, we'll let you know.
  - Early departures are non-refundable.
- Campsites must be left clean; a \$150 fee applies for messes or damage.

### SITE LIMITATIONS AND PROVISIONS

- Respect others' space; do not walk through occupied sites.
- Campsite capacities vary—check specifications before booking.
- Electrical Use:
  - Only plug trailers/RVs into appropriately rated outlets.
  - Damaged outlets or equipment incur fees starting at \$75.
  - Repeated breaker trips may result in service loss.
  - Use of "high draw" devices may result in additional fees (ice makers, cooktops, etc.)

### SOUND AND NOISE

- **Quiet Hours:** 12:00 am - 9:00 am
  - No loud music, barking dogs, or excessive noise.
  - Generators prohibited during quiet hours.
  - No vehicle idling at any time.
- **Non-Quiet Hours:** 9:00 am - 11:59 pm
  - Maintain reasonable noise levels.
  - Use quiet generators (45db or lower) in designated areas.

### DRIVING, PARKING, VEHICLES & SPEED

- Eagle Creek is a pedestrian-friendly park:
  - One vehicle per campsite. Additional vehicles must be parked in designated areas.

- Speed limit: 10 km/h. Violators will lose driving privileges.
- Mobility scooters for accessibility are permitted (6-8 km/h max) with park approval.
- Golf carts and other motorized vehicles require management approval.
- Vehicles must stay on main roads, no driving on trails, grass, or wooded areas.

#### **FIRE & OPEN FLAMES**

- Fires must never be left unattended.
- Follow local fire restrictions and bans.
- Fires must remain within designated fire rings and be no larger than 24" x 24".
- Fully extinguish fires before leaving: no heat, smoke, or embers should remain. Violations may result in a \$50 fine.
- **No outside firewood allowed.** Transporting firewood is prohibited to prevent pest spread.

#### **WASHROOM FACILITIES**

- Keep washrooms clean and sanitary. We aim to keep these facilities ready for use by all members, please do your part to ensure you leave the space suitable for the next person.
- Inform management of any concerns or needs in the facilities.

#### **GARBAGE & RECYCLING**

- Short-term guests must carry out their refuse. Dumpsters are for seasonal members only.
- Garbage must be bagged in black bags; recycling sorted.
- Littering fines start at \$250 plus clean-up costs.
- Disposal of hazardous waste is prohibited and subject to fines starting at \$2,000.

#### **CONDUCT & SAFETY**

- Respect others' consent and property.
- Violence or harassment of any kind will result in eviction without refund and possible legal action.
- Excessive intoxication or disturbances will not be tolerated.
- Clothing is required in common areas. Nudity is permitted on your site and designated areas. Clothing is required when traversing between sites or common areas.
- Explicit consent is required for all sexual activity. This includes passive participation of activity that can be seen by park pedestrians. Activity on your site is permitted but must be reasonably discrete to those passing by.
- Damage to park property will result in restitution.

#### **ALCOHOL, ILLEGAL SUBSTANCES, WEAPONS & FIREWORKS**

- Alcohol is permitted; illegal substances are not.
- Selling or distributing illegal substances results in eviction, membership revocation, and a ban.
- Weapons and personal fireworks are strictly prohibited.

#### **SMOKING**

- Dispose of cigarette butts in appropriate receptacles. Improper disposal is considered littering and subject to a \$250 fine.
- Smoking is prohibited in cabins, motel rooms, washrooms, dance hall, office, and other designated areas.

#### **PHOTOGRAPHY, VIDEO & DRONES**

- Photography is allowed on your site if focused inward and with consent.
- Commercial photography requires management approval.
- Drones and RC cameras require management consent.

#### **PETS**

- Pets must always be leashed in common areas. Pets must be under control on sites.
- In the Off-Leash Area, pets must remain under voice control.
- Clean up after pets; violations result in fines starting at \$500.
- Aggressive pets or excessive barking may result in removal from the park.
- Pets must have current applicable licenses, vaccinations, and identification tags.
